CHESTERFIELD CANAL PUBLIC PATH ORDER (No 1) 2024

**DIVERSION OF UNRECORDED TRANS PENNINE TRAIL (PART),
STAVELEY BRIDLEWAY 48 AND STAVELEY FOOTPATH 1 (PART),
STAVELEY FOOTPATH 50 AND STAVELEY FOOTPATH 71 (PART).**

This order is made by Chesterfield Borough Council under section 257 of the Town and Country Planning Act 1990 because it is satisfied that it is necessary to divert the footpaths and bridleways to which this order relates in order to enable development to be carried out in accordance with planning permission granted under Part III of the Town and Country Planning Act 1990 namely: planning permission reference CHE/20/00420/FUL for reinstatement of former Chesterfield Canal along its route between Staveley Basin/Eckington Road overbridge and Hague Lane Renishaw, Staveley, Chesterfield.

BY THIS ORDER:

1. The footpaths and bridleway over the land shown by bold solid black lines on the attached map and described in Part 1 of the Schedule to this order ("the Schedule") shall be diverted or extinguished as provided below:
2. There shall be created to the reasonable satisfaction of Chesterfield Borough Council alternative highways for use as replacements for the said footpaths and bridleway as provided in Part 2 of the Schedule and shown by bold and none bold black dashes on the attached map.
3. The diversion of the footpaths and bridleways shall have effect on the date on which Chesterfield Borough Council certify that the terms of Part 2 have been complied with.
4. The following works shall be carried out in relation to the highways described in Part 2 of the Schedule:
 - a) The new footpaths and bridleways will be 3.0 metres wide with surface material of a compacted stone similar to that used for the towpath on the existing restored lengths of the canal.

- b) For the Bridge the diverted footpath and bridleway will be 3.0 metres wide with an approved surface material in accordance with British Horse Society guidance.
5. The developer of the canal restoration scheme (The Chesterfield Canal Trust Ltd) is hereby required to pay for the cost of carrying out the said works.
6. Where immediately before the date on which the footpaths and bridleways are diverted there is apparatus under, in, on, over, along or across it belonging to statutory undertakers for the purpose of carrying out their undertaking, the undertakers shall continue to have the same rights in respect of the apparatus as they then had.

PART 1

Section as indicated on map	DESCRIPTION OF SITE OF EXISTING FOOTPATHS AND BRIDLEWAYS
Footpath 1 (and TPT) A-B-C	The whole width of that part of Staveley Footpath 1 (which is also part of the Trans Pennine Trail) commencing at Point A (GR 44346 37531) and proceeding in an easterly direction for a distance of approximately 140 metres to Point B (GR 44360 37533) and then proceeding in a north direction for a distance of approximately 6 metres and then in a west direction for a distance of approximately 6 metres to Point C (GR 44359 37534).
Footpath 50 (and TPT) B-D	The whole width of that part of Staveley Footpath 50 (which is also part of the Trans Pennine Trail) commencing at Point B (GR 44360 37533) and proceeding in a generally east south easterly direction for a distance of approximately 160 metres to Point D (GR 44373 37525) where it adjoins Staveley FP49.
Footpath 71 E-F-V-G	The whole width of that part of Staveley Footpath 71 commencing at point E (GR 44359 37536) and proceeding in a generally east south easterly direction for a distance of approximately 95 metres to Point F (GR 44367 37533) and then in an easterly direction for a distance of approximately 15 metres to point V (GR44370 37533) and onwards for a further 60 metres to Point G (GR 44374 37533).
Bridleway 48 (and TPT) H-V-U-Q	The whole width of Staveley Bridleway 48 (which is also part of the Trans Pennine Trail) commencing at Point H (GR 44368 37535) and proceeding in a generally south easterly direction through points V (GR 44370 37533) and U (GR 44374 37531) for a distance of approximately 100 metres to Point Q (GR 44376 37529).

**Unrecorded
route (TPT)
N-O-P-Q**

The whole width of that part of the unrecorded route of the Trans Pennine Trail commencing at Point N (GR 44379 37541) and proceeding in a generally south south westerly direction for a distance of approximately 45 metres to Point O (GR 44377 37538), then proceeding in a generally south south east direction for a distance of approximately 60 metres to point P (GR 44378 37533) and then proceeding in a generally south south westerly direction for a distance of approximately 50 metres to Point Q (GR 44376 37529). The section between points P and Q traverses an existing embankment by means of a flight of steps.

route (TPT)
O-K**

The whole width of that part of the unrecorded route of the Trans Pennine Trail commencing at Point O (GR 44377 37538) proceeding in a generally west south westerly direction for a distance of approximately 65 metres to Point K (GR 44371 37535)

DESCRIPTION OF SITE OF NEW FOOTPATHS AND BRIDLEWAYS

A-B

A 3.0 metre wide footpath commencing at Point A (GR 44346 37531) and proceeding in an easterly direction for a distance of approximately 140 metres to Point B (GR 44360 37533) The route is diverted along this length onto the existing provided pathway.

B-D

A 3.0 metre wide footpath commencing at Point B (GR 44360 37533) and then proceeding in in east south easterly direction for a distance of approximately 160 metres to Point D (GR 44373 37525) where it adjoins Staveley FP49. The route is diverted along this length onto the existing provided pathway.

G-H-I-J

A 3.0 metre wide footpath commencing at Point G (GR 44374 37533) and proceeding through Point H (GR 44368 37535) in a generally west north westerly direction for a distance of approximately 170 metres to Point I (GR 44360 37539) before proceeding in a north north west direction for a further 50 metres to Point J (GR 44359 37544) where it adjoins Eckington Road. The route is diverted onto the existing provided pathway.

N-W-R-Q-S-T

A 3.0 metre wide bridleway commencing at Point N (GR 44379 37541) proceeding in a generally south south westerly direction through Points W (GR 44379 37538), R (GR 44377

37533), Q (GR 44376 37529) and S (GR 44375 37526) for a distance of approximately 160 metres where it joins Staveley FP49 and then proceeding in a south east direction for approximately 35 metres to Points T (GR 44378 37524) where it joins Staveley Bridleway 47 and the unrecorded route of the TPT. The section from just north of Point R to just north of Point Q is on a bridge at 3.0 metres width.

N-M-L-K

A 3.0 metre wide footpath commencing at Point N (GR 44379 37541) and proceeding in a curved form generally to the southwest for a distance of approximately 30 metres to point M (GR 44377 37540) and then curved to the south west for a distance of approximately 50 metres before reaching Point L (GR 44373 37537) and then in a south west direction for a distance of approximately 30 metres to Point K (GR 44371 37535).

L-G

A 3.0 metre wide footpath commencing at Point L (GR 44373 37537) and proceeding in a south south easterly direction for a distance of approximately 50 metres to Point G (GR 44374 37533) where it joins Staveley FP71.

M-W

A 3.0 metre wide footpath commencing at Point M (GR 44377 37540) proceeding in a generally curved south east direction for a distance of approximately 20 metres to Point W (GR 44379 37538).

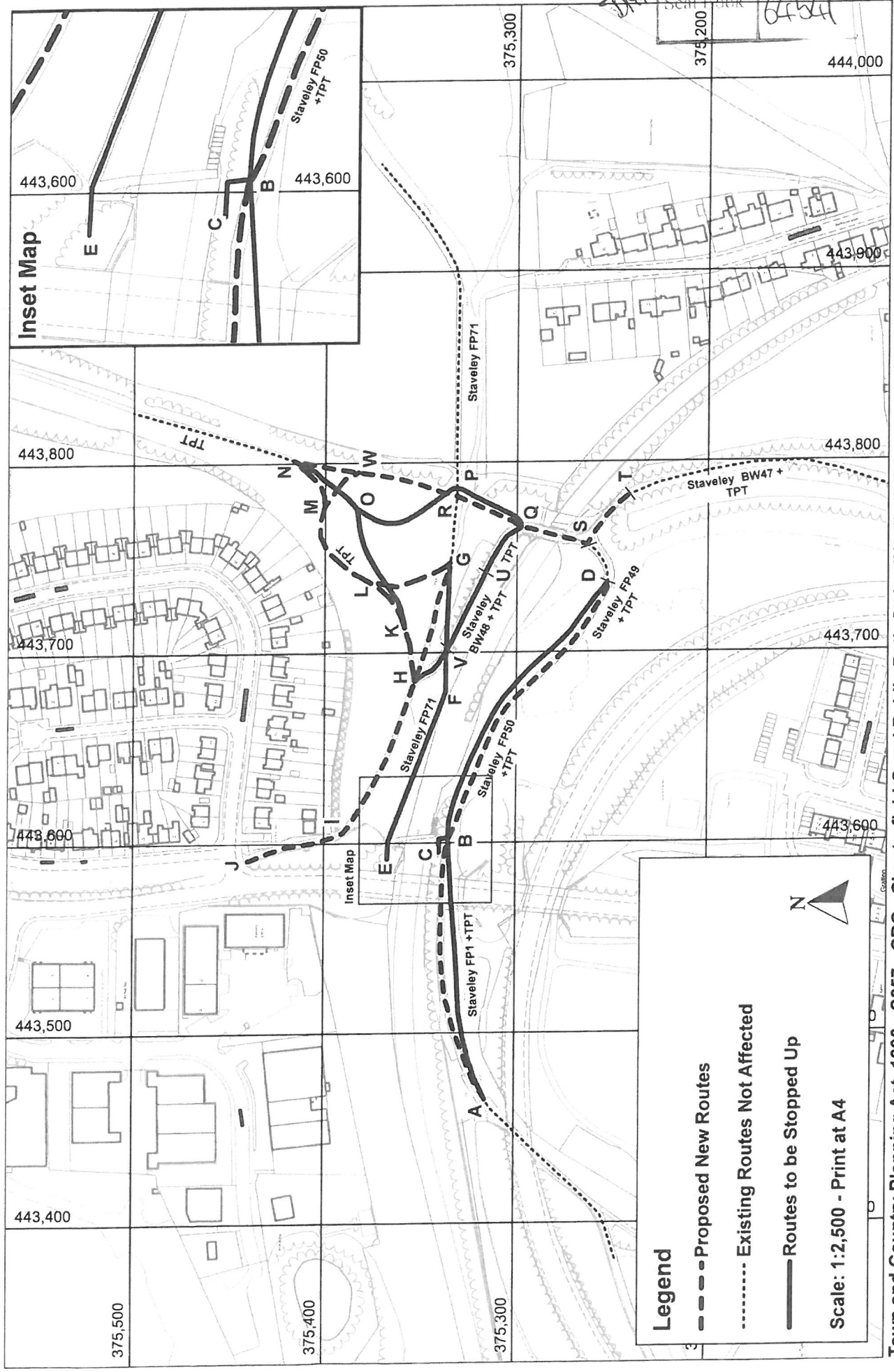
